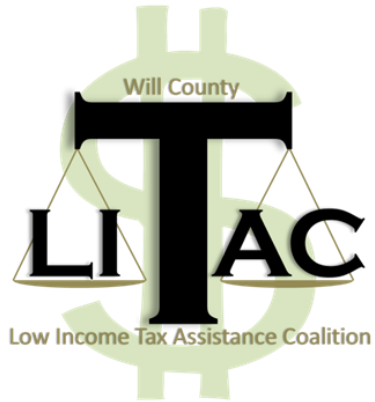


# FREE TAX RETURN PREPARATION

## WHAT TO BRING:

- Photo identification for yourself and spouse
- Social Security cards or Individual Taxpayer Identification notices/cards for you, your spouse, and all dependents
- Birth dates for you, spouse and all dependents on the return
- For homeowners, a copy of your most recent tax bill
- Wage and earning statements (Form W-2, W-2G, 1099-G, 1099-R, 1099-Misc) from all employers/payors
- Tuition statement (Form 1098-T) for yourself or dependents
- Interest and dividend statements (1099-INT and 1099-DIV)
- A copy of last year's federal and state returns, if available
- Bank account routing and account numbers for direct deposit
- Total paid for daycare and the daycare provider's tax ID number such as their Social Security number or business EIN
- Forms 1095-A, B or C, Affordable Health Care Statements
- To file taxes electronically on a married-filing-joint tax return, both spouses must be present to sign the required forms
